

The Sankaralingam Bhuvanewari College of Pharmacy, Sivakasi, on behalf of the Department of **PHARMACEUTICS** shall apply to this University six months before the expiry of the present recognition by remitting the prescribed inspection fee for the grant of the continuance of Recognition of the said department for the purpose of Ph.D. Programme.
